## APPLYING FOR A VISA AT HULL IN PERSON

INFORMATION ABOUT APPLYING FOR A NON-IMMIGRANT CATEGORY "B" VISA BY PERSON WISHING TO ATTEND A BUSINESS CONFERENCE OR TRADE FAIR OR TO GIVE A TALK OR LECTURE IN THAILAND

ALL INFORMATION PROVIDED IS ON THE BASIS THAT THE APPLICANT WILL BE APPLYING FOR THEIR VISA
IN PERSON AT THE ROYAL THAI CONSULATE HULL
PERSONS INTENDING TO APPLY ELSEWHERE FOR THEIR VISA NEED TO CHECK WITH THE RELEVANT AUTHORITY

PLEASE NOTE THAT THE ISSUING OF ALL NON IMMIGRANT VISAS MUST BE AUTHORISED BY THE THAI IMMIGRATION AUTHORITY PRIOR TO BEING ISSUED AND THIS PROCESS CAN TAKE UP TO ONE WEEK.

WHEN WE RECEIVE AUTHORITY TO ISSUE THE VISA WE WILL INVITE THE APPLICANT TO VISIT US AND THE VISA WILL BE ISSUED, USUALLY WITHIN ONE HOUR

The non-immigrant category B visa is available for persons who are travelling to Thailand for the purpose of attending a Business Conference/Trade Fair or to give a Talk or Lecture in Thailand.

This visa is available with single entry only. It is valid for three months from date of issue and allows a single stay in Thailand of up to 90 days commencing on the day of entry.

So that we can obtain authorisation from the Thai Immigration Authority to issue this visa it is necessary for the applicant to e-mail to us scans of all the following documents which are relevant to applying for this visa:-

- 1. Completed Visa Application Form with two recent passport size photographs attached.
- **2.** Page of applicant's passport containing photo and details. Passport must have minimum 6 months validity at time of travel.
- **3.** Letter of Invitation from Thai Conference/Trade Fair/Talk/Lecture organisers stating reason for visit.
- **4.** Letter from applicant's employer.
- 5. Copy of return flight ticket.
- 6. Copy of accommodation booking.

As soon as we receive approval from the Thai Immigration Authority to grant the visa we will invite the applicant, or someone else acting for the applicant, to visit us and bring with them the following so that we can issue the visa into the applicant's passport:-

- a) Passport with minimum 6 months remaining validity at time of travel and with at least two blank pages for the visa and for entry/exit stamps.
- b) Original completed Visa Application Form with two passport type photos attached.
- c) Visa fee until 31 March 2019: £50 (single entry) plus £10 processing charge total of £60 in cash only. Visa fee from 1 April 2019: £60 (single entry) plus £10 processing charge total of £70 in cash only.

Please note that only a single entry visa will be granted allowing a single stay of 90 days. It may be possible to extend the stay by visiting a Thai Immigration Office near to where you will be staying.
