



## Royal Thai Consulate Hull

### APPLYING FOR A NON-IMMIGRANT CATEGORY “O” VISA TO VISIT SPOUSE OR PARENT WHO IS WORKING IN THAILAND

**ALL INFORMATION PROVIDED IS ON THE BASIS THAT THE APPLICANT WILL  
BE APPLYING FOR THEIR VISA FROM THE ROYAL THAI CONSULATE AT HULL.**

***PLEASE NOTE THAT THE ISSUING OF ALL NON-IMMIGRANT VISAS MUST BE AUTHORISED BY THE  
THAI IMMIGRATION AUTHORITY PRIOR TO BEING ISSUED AND THIS PROCESS CAN TAKE UP TO ONE WEEK.***

***WHEN WE RECEIVE AUTHORITY TO ISSUE THE VISA WE WILL CONTACT THE APPLICANT AND INFORM THEM. IT WILL  
THEN BE NECESSARY FOR THEM TO PROVIDE THEIR PASSPORT SO THAT THE VISA CAN BE AFFIXED TO A PAGE OF IT.***

**The Non-Immigrant category O visa is available to persons who are travelling to Thailand on the  
basis of being married to someone who is working in Thailand.**

**The visa is valid for three months from the date of issue and it allows a single stay for up to 90 days.**

**If wishing to remain in Thailand longer it will be necessary to visit a Thai Immigration Office near to where  
you will be staying in Thailand and request an extension of stay. The granting of an extension of stay  
will be solely at the discretion of Thai Immigration.**

**If, when in Thailand, you wish to stay longer than the 90 days it will be necessary to visit a Thai Immigration  
Office near to where you are staying in Thailand and request an extension of stay.**

**So that we can obtain authorisation from Thai Immigration to issue this visa it is necessary for the applicant  
to email to [enquiries@thaiconsul-uk.com](mailto:enquiries@thaiconsul-uk.com) scans of ALL the following documents:-**

1. Page of your passport containing your photo and details. It must have minimum 6 months remaining validity at time of applying for the visa.
2. Completed **Hull** Visa Application Form **with two recent passport size photographs attached.**
3. Copy of passport of person working in Thailand – **page containing photo and details.**
4. Copy of passport of person working in Thailand – **page containing relevant B visa.**
5. Copies of all pages (not blank ones) of valid Thai Work Permit of person working in Thailand.  
**or**  
Copies of **all pages** of Contract of Employment of person going to be working in Thailand.
6. If married to person working in Thailand, copy of Marriage Certificate.  
**or**  
If child of person working in Thailand, copy of Birth Certificate.

**As soon as we receive authority to grant you the visa we will inform you and then you will need to  
provide us with your passport and the fee (£70) **in cash only** so that we can issue the visa  
and affix it to a page of your passport.**
