



## Royal Thai Consulate Hull

### **APPLYING FOR A NON-IMMIGRANT CATEGORY “B” VISA FOR NON-THAI PERSON TO DO BUSINESS WITH COMPANY BASED IN THAILAND**

**ALL INFORMATION PROVIDED IS ON THE BASIS THAT THE APPLICANT WILL  
BE APPLYING FOR THEIR VISA FROM THE ROYAL THAI CONSULATE AT HULL.**

*PLEASE NOTE THAT THE ISSUING OF ALL NON-IMMIGRANT VISAS MUST BE AUTHORISED BY THE  
THAI IMMIGRATION AUTHORITY PRIOR TO BEING ISSUED AND THIS PROCESS CAN TAKE UP TO ONE WEEK.*

*WHEN WE RECEIVE AUTHORITY TO ISSUE THE VISA WE WILL CONTACT THE APPLICANT AND INFORM THEM. IT WILL  
THEN BE NECESSARY FOR THEM TO PROVIDE THEIR PASSPORT SO THAT THE VISA CAN BE AFFIXED TO A PAGE OF IT.*

The Non-Immigrant Category “B” Visa is available to persons who will be travelling to Thailand for the purpose of doing business with an organisation in Thailand.

The visa is valid for three months from the date of issue and it allows a single stay for up to 90 days.

If wishing to remain in Thailand longer it will be necessary to visit a Thai Immigration Office near to where you will be staying in Thailand and request an extension of stay. The granting of an extension of stay will be solely at the discretion of Thai Immigration.

So that we can obtain authorisation from Thai Immigration to issue this visa it is necessary for the applicant to email to [enquiries@thaiconsul-uk.com](mailto:enquiries@thaiconsul-uk.com) scans of ALL the following documents:-

1. Page of your passport containing your photo and details. It must have minimum 6 months validity at the time of applying for the visa.
2. Completed Hull Visa Application Form **with two recent passport size photographs attached.**
3. Letter, which must be in English language, from the organisation which applicant is employed by or is representing, requesting a business visa and stating reasons why.
4. Letter of Invitation which must be in English from Thai trading partner company stating objective(s) of visit.
5. Copy of corporate registration documents and licence from Thai Company (these will be in Thai).

**As soon as we receive authority to grant you the visa we will inform you and then you will need to provide us with your passport and the fee (£70) **in cash only** so that we can issue the visa and affix it to a page of your passport.**
