INFORMATION ABOUT OBTAINING A NON-IMMIGRANT CATEGORY “B” VISA WITH SINGLE ENTRY ONLY BY PERSON WHO WILL BE WORKING ON A SHIP OR YACHT OR SIMILAR OPERATING OUT OF THAILAND

ALL INFORMATION PROVIDED IS ON THE BASIS THAT THE APPLICANT WILL BE APPLYING FOR THEIR VISA IN PERSON AT THE ROYAL THAI CONSULATE HULL. PERSONS INTENDING TO APPLY ELSEWHERE FOR THEIR VISA NEED TO CHECK WITH THE RELEVANT AUTHORITY.

PLEASE NOTE THAT THE ISSUING OF ALL NON IMMIGRANT VISAS MUST BE AUTHORISED BY THE ROYAL THAI EMBASSY LONDON PRIOR TO BEING ISSUED AND THIS PROCESS CAN TAKE UP TO ONE WEEK. WHEN WE RECEIVE AUTHORITY TO ISSUE WE WILL INVITE YOU TO VISIT US AND THE VISA WILL BE ISSUED USUALLY WITHIN ONE HOUR.

The non-immigrant category B visa with single entry only is available for persons who are travelling to Thailand to take up employment on-board a foreign registered yacht operating out of Thailand.

The single entry visa is valid for three months from date of issue and allows a single stay in Thailand of up to 90 days.

So that we can obtain authorisation from the London Embassy to issue this visa it is necessary for the applicant to submit to us all documents relative to this visa therefore we request you to email scanned copies of the following to enquiries@thaiconsul-uk.com:-

- A) Completed Visa Application Form with two recent passport size photos attached.
- B) Page of your passport containing your photo and details.
- C) Supporting Letter from the organisation which applicant will be employed by which must include the official registration stamp of the ship and be signed by the ship's captain.
- D) Copy of the corporate registration documents of the ship.

As soon as we receive authority from the London Embassy we will invite you to visit us so that we can issue the visa and you will need to bring with you the following:-

1. Your passport (minimum 6 months remaining validity and with at least two blank pages for the visa and for entry/exit stamps).
2. Two recent passport size photographs as available from a photo booth.
3. Original completed Visa Application Form with two recent passport size photos attached.
4. Visa fee **until 31 March 2019**: £50 (single entry) plus £10 processing charge - total of **£60 in cash only**.
Visa fee **from 1 April 2019**: £60 (single entry) plus £10 processing charge - total of **£70 in cash only**.
